About mid December 2022 I was alerted by our accounting department that our water/sewer bill had increased by a large amount and we may have a problem. I went around the store investigated and tried to find any leaks or problems that could be happening within the store. I was unable to find anything. I called out the water district soon after that to help out and they could not find anything either.

Shortly after that I did notice a small leak coming from underneath one of Ice Machines out front of the store. I called Tillamook Ice they came out and there was no leakage from the ice machine. After a week I was able to get the ice machine moved and discovered the water coming up from the natural division from the concrete pours. It was a very small amount trickling out. I then look at my water mains inside the store in the deli area, made some holes in sheetrock to see if there was any leaks there and found nothing.

We then got a hold of Page Construction and they came on January 10, 2023, cut the concrete and we discovered a large water flow coming out from the broken pipe. The water flow was a lot, however very little was reaching the surface so made us unaware of the severity of the problem. Page construction was able to fix it that day. I do accept that the water break was our responsibility and the usage of that water even from the break is ours. However I know our sewer usage is based on usage. During this period we did not use as much sewer due to our break in the water coming into the store. So I am asking if we coud get some relief on our swerve bill for the last few months. We have worked to be diligent to fix this problem once we were able to narrow it down to where it was coming from. If you have any questions or concerns please let me know.
